



APPLICATION FOR NEW JERSEY RESIDENCY FOR IN-STATE TUITION PURPOSES

COPY THIS FORM AS NEEDED

Students who are classified as non-residents may petition for in-state residency to the Office of the Registrar. All supplemental documentation should accompany this application. You will be notified in writing of your residency reclassification approximately ten business days following receipt of your request.

A student is a resident of New Jersey if he/she has maintained their legal residence for a period of twelve months prior to enrollment. Dependent students must claim residency of parent or legal guardian. In conformance with New Jersey legislation, military personnel and their dependents that are attending public institutions of higher education in New Jersey are considered New Jersey residents. (N.J.S.A. 18A:62-4.1)

To determine whether a person is a New Jersey domiciliary, the primary evidence is a New Jersey Resident Income Tax Return or in the case of a dependent student, a copy of his/her parent(s) legal guardian's/spouse's New Jersey Resident Income Tax return. Supplementary evidence may include current voter registration card, New Jersey driver's license and New Jersey motor vehicle registration.
